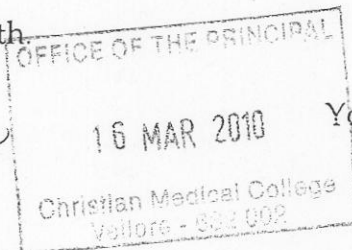
Sir,

In reference to above, I am to state that the Postgraduate Committee of this Council at its meeting held on 26th & 27th Feb, 2010 considered the compliance verification inspection report (January 2010) on the physical and other teaching facilities available at the Christian Medical College, Vellore for increase of seats in MD (General Medicine) course under the Tamilnadu Dr.MGR Medical College, Tamilnadu u/s 10A of the IMC Act, 1956. The Committee decided as under which I am directed to convey herewith for your information & necessary action:-

*"The Postgraduate Committee considered the compliance verification inspection report (January, 2010) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD(General Medicine) course at Christian Medical College, Vellore under The Tamilnadu Dr.MGR Medical College, Tamilnadu u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2010-2011 from 6(Six) to 8(Eight) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956."*
