It is stated that the assessment report (April, 2013) on the standard of examination and other teaching facilities available at Christian Medical College, Vellore for purpose of Recognition of MD(General Medicine) qualification against increased intake from 06(Six) to 08(Eight) seat(s) granted by The Tamilnadu Dr. MGR Medical University, Chennai was considered by the Board of Governors at its meeting held on 03.07.2013 and it was decided as under:-

"The Board of Governors considered the assessment report (April, 2013) and noted that MD(General Medicine) qualification is already recognized with 06(Six) seat(s) and decided to recommend that MD(General Medicine) qualification against increased intake from 06(Six) to 08(Eight) seat(s) granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Christian Medical College, Vellore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 08(Eight) student(s) per year."

The Board of Governors further decided that the attention of the institute be drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- Failure to seek timely renewal of recognition as required in sub-cluase-4 shall invariably result in 6.6 stoppage of admissions to the concerned Post Graduate Course.
