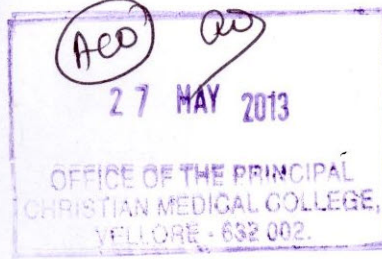

The Permission is, however, subject to the condition that admission process may be completed as per time schedule prescribed in the Regulations of Medical Council of India.

- (iii) No admission is permitted beyond the cut-off date.

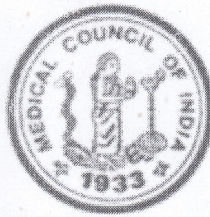

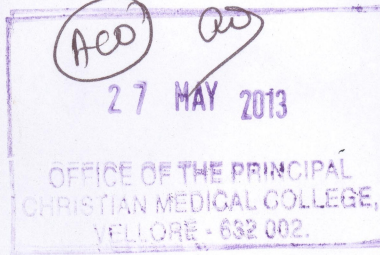
