The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Assessment Report (August, 2014) and decided to recommend that DM (Cardiology) qualification against increased intake from 3 to 6 granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Christian Medical College, Vellore, Tamil Nadu be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.
