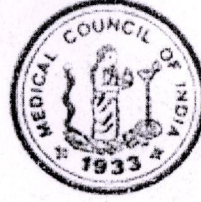

Sub: The Tamilnadu Dr. MGR Medical University, Chennai - Recognition of M.Ch(Endocrine Surgery) qualification for 1(One) seat in respect of students being trained at Christian Medical College, Vellore, Tamil Nadu.

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 26-27/03/2015 considered the Council Assessor's Report (August, 2014) and Compliance dated 24/10/2014 submitted by the College Authorities on the physical and other teaching facilities available at Christian Medical College, Vellore, Tamil Nadu for the award of M.Ch(Endocrine Surgery) qualification for 1(One) seat under The Tamilnadu Dr. MGR Medical University, Chennai. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (August, 2014) and Compliance dated 24/10/2014 submitted by the College Authorities and decided to recommend to the Central Government that M.Ch.(Endocrine Surgery) qualification for 1(One) seat granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Christian Medical College, Vellore, Tamil Nadu be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

You are therefore requested to notify the above qualification at the earliest.
