Sir,

I am to state that Council Inspector report (Nov. 1987) on the standard of examination and facilities for teaching existing at Madras Medical College, Madras for continuance of recognition and also approval of Christian Medical College, Vellore together with the observations of the University and recommendations of the Postgraduate Committee for the award of D.P.M. qualification granted by University of Madras/Dr. M.G.R. Medical University, was duly placed before the Council at its meeting held on 4th January, 1992 for consideration. The Council approved the following recommendations of the Postgraduate Committee, which I am directed to forward herewith for your information and necessary action in the matter :-

"The Postgraduate Committee recommends that D.P.M. qualification granted by Madras University/Dr. M.G.R. Medical University, Madras in respect of students being trained at Madras Medical College, Madras be continued. The Postgraduate Committee also recommends that Christian Medical College, Vellore be approved for the award of D.P.M. qualification granted by Madras University/Dr. M.G.R. Medical University and the attention of the authorities concerned be drawn towards implementation of various recommendations and suggestions made by the Council Inspector in the inspection report. However, no seat to the existing seats should be increased without prior approval of the Council."

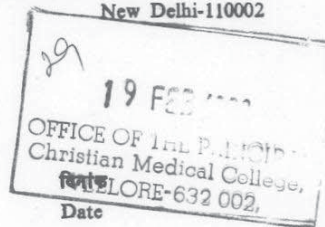
